Suitability to Sail : Medical Pregnancy and Medical Conditions

Due to the unpredictable movement of the boat, this may aggravate existing medical conditions. You must inform us of any material fact including medical conditions or disabilities, which may effect the Ships Master’s decision to carry you as a passenger.

Conditions include epilepsy, diabetes, angina and other heart conditions, back and spinal conditions, bone weakening conditions such as Osteoporosis.

None of our voyages are suitable if you are pregnant.

You must inform the Ships Master of any medical conditions before boarding.

Due to the unpredictable movement of the boat, voyages are not suitable for passengers who cannot effectively brace themselves – this may include the frail, elderly or young children.

The staff of RIB Skippers Ltd, are not qualified to make a suitable judgement or give medical advice that may be necessary in order to determine your fitness to sail.

The decision to sail and any consequences of participating in any voyage by RIB Skippers Ltd is done entirely at the passenger’s own risk.

RIB Skippers Ltd does not accept any liability for personal injury, or injury to others and / or loss or damage (but only so far as such injury is not caused by RIB Skippers Ltd negligence).

Activation of Emergency Equipment & Life Jackets
